CONSENT FOR PARTICIPATION AND USE OF PHOTOGRAPH AND/OR INTERVIEW FOR PUBLICATION

LAND and its affiliated entities will not act as my agent for any purpose whatsoever, including with respect to any professional athletic endeavor.
My participation in interviews or other activities with LAND may entail some level of personal risk, including physical risk which may arise, for example, during an in-person interview or activity. I understand and accept these risks and, to the greatest extent possible, release and waive any claims against the Released Parties that may arise in connection with my participation.
I hereby release LAND, its officers, directors, employees, agents, representatives, and its affiliated partner entities (the "Released Parties") from any action, claim, or liability whatsoever, including, but not limited to, any claim of ownership or control over the Content, except as expressly provided for in this Consent, or as may arise in connection with negligence or gross negligence of any Released Party.
I may revoke this Consent at any time by contacting LAND in writing at 1400 E Angela Blvd., Suite 134, South Bend, Indiana 46617, (703) 431-1801. Revocation will not apply to information that has already been released or other actions that have been taken based on this Consent.
This Consent shall be governed, to the greatest extent possible, by Indiana law, notwithstanding its choice of law provisions.
